



Terms and Conditions for the Tiny Seeds 50:50 Cash Raffle

These terms and conditions apply to the Tiny Seeds 50:50 Cash Raffle (“the Raffle”) organised by Tiny Seeds (“the Organiser”). This Raffle is licensed and regulated by the Jersey Gambling Commission.

1. General

1.1. These terms and conditions (the “Terms”) apply to the Raffle and take precedence over any conflicting information, including advertising or promotional materials. By entering, all participants (each an “Entrant”) agree to be bound by these Terms.

1.2. The Raffle is operated by Tiny Seeds, registered in Jersey. The Raffle complies with the Gambling Commission laws in Jersey and all relevant regulations.

2. Eligibility

2.1. The Raffle is open for entries from the start date until the Closing Date as specified in the Promotion Literature. The key dates are:

- Online ticket sales close: Wednesday 30th April at midnight.
- In-person ticket sales close: Monday 5th May at 2:00 PM.
- Draw takes place: Monday 5th May at 4:00 PM at the Jersey Boat Show.

2.2. To enter, you must:

- Be 18 years or older.
- Be a Jersey resident.

- Not be a board member or employee of Tiny Seeds, their partner or someone directly involved in the running of the Raffle.

2.3. Any entries deemed inappropriate, offensive, copied, or fraudulent may be disqualified at the Organiser's discretion.

2.4. Incomplete, late, or misdirected entries will not be accepted. Proof of sending is not proof of receipt.

2.5. The Organiser reserves the right to disqualify any entries that do not comply with these Terms. Anyone attempting to manipulate the entry process may also be disqualified.

3. The Prizes

3.1. A maximum of 6,000 tickets are available for purchase at £5 each.

3.2. The prizes are:

- 1st Prize: 50% of the total ticket sales, with a guaranteed minimum cash prize of £500.
- 2nd Prize: Return flights for two people with Blue Islands from Jersey to UK airports, Dublin, or Paris. The winner must comply with Blue Islands' own terms and conditions.
- 3rd Prize: Champagne Afternoon Tea for two at the Radisson Blu Waterfront Hotel in Jersey.

3.3. The 1st prize amount will be confirmed on the day of the draw based on the total number of tickets sold.

3.4. Prizes must be accepted as awarded and are non-transferable. Prizes cannot be exchanged for an alternative.

3.5. If a winner does not claim their prize within 6 weeks of being contacted, the Organiser reserves the right to withdraw the prize and select a new winner.

4. Cancellations and Refunds

4.1 The Organiser reserves the right to cancel, amend, or suspend the Raffle in the event of unforeseen circumstances.

4.2 In the event of cancellation before the draw takes place, all ticket holders will be entitled to a full refund of the purchase price paid for their tickets. Refunds will be processed within 30 days of the cancellation notice.

4.3 If the raffle is postponed, all tickets will remain valid for the rescheduled draw. If a ticket holder is unable to participate in the rescheduled draw, they may request a refund within 14 days of the announcement of the new date.

4.4 Tickets are non refundable outside of the circumstances outlined in this section.

4.5 The Organiser will not be responsible for any additional costs incurred by Entrants due to cancellation, postponement or changes to the Raffle.

5. Entry

5.1. To enter the Raffle, Entrants must:

- Meet the eligibility criteria in Section 2.
- Purchase a ticket in accordance with the instructions in the promotional literature.

5.2. Entrants are responsible for providing correct and up-to-date contact details. The Organiser cannot be held responsible for any issues arising from incorrect details being provided.

5.3. The winner will be randomly selected by a physical prize draw.

5.4. Winners will be contacted on the day of the draw. If a winner cannot be reached after reasonable attempts, after 6 weeks the Organiser reserves the right to withdraw the prize and select a new winner.

5.6. Winners must collect their prizes in person and provide photo ID as proof of age and Jersey residency.

6. Limitation of Liability

6.1. Entry into the Raffle is at the Entrant's own risk. The Organiser is not responsible for any loss, damage, or injury resulting from participation, except in cases of negligence.

7. Data Protection and Privacy

7.1. The Organiser complies with the Data Protection (Jersey) Law 2018 and is registered with the Jersey Office of the Information Commissioner (JOIC).

7.2. By entering, you agree to your personal data (e.g., name, email, address) being processed to administer the Raffle.

7.3. The Organiser will not share your personal data with third parties for marketing without your consent.

7.4. If you wish to access, correct, or restrict processing of your personal data, or opt out of any future communications, please contact the Organiser.

7.5. If you have concerns about data handling, you may contact the Jersey Office of the Information Commissioner.

7.6. Winners details may be shared with the Jersey Gambling Commission for regulatory compliance.

8. General

8.1. If any part of these Terms is found to be unenforceable, the rest of the Terms will remain valid.

8.2. The Organiser is governed by Jersey law, and any disputes will be handled by the Jersey courts.

8.3. The Organiser may update these Terms as needed, with any changes taking effect immediately once published.

8.4. The Organiser's decisions regarding the Raffle are final.

9. Amendments to Terms and Conditions

- The Organiser reserves the right to amend these terms and conditions at any time, provided that the amendments are communicated to participants before the Raffle is drawn.

Important Notes

- Winners should ensure they review the individual terms and conditions for the 2nd Prize flights and 3rd Prize afternoon tea when claiming their prizes.

- By purchasing a ticket, you agree to the terms and conditions set out above, and confirm that you meet the eligibility requirements.
